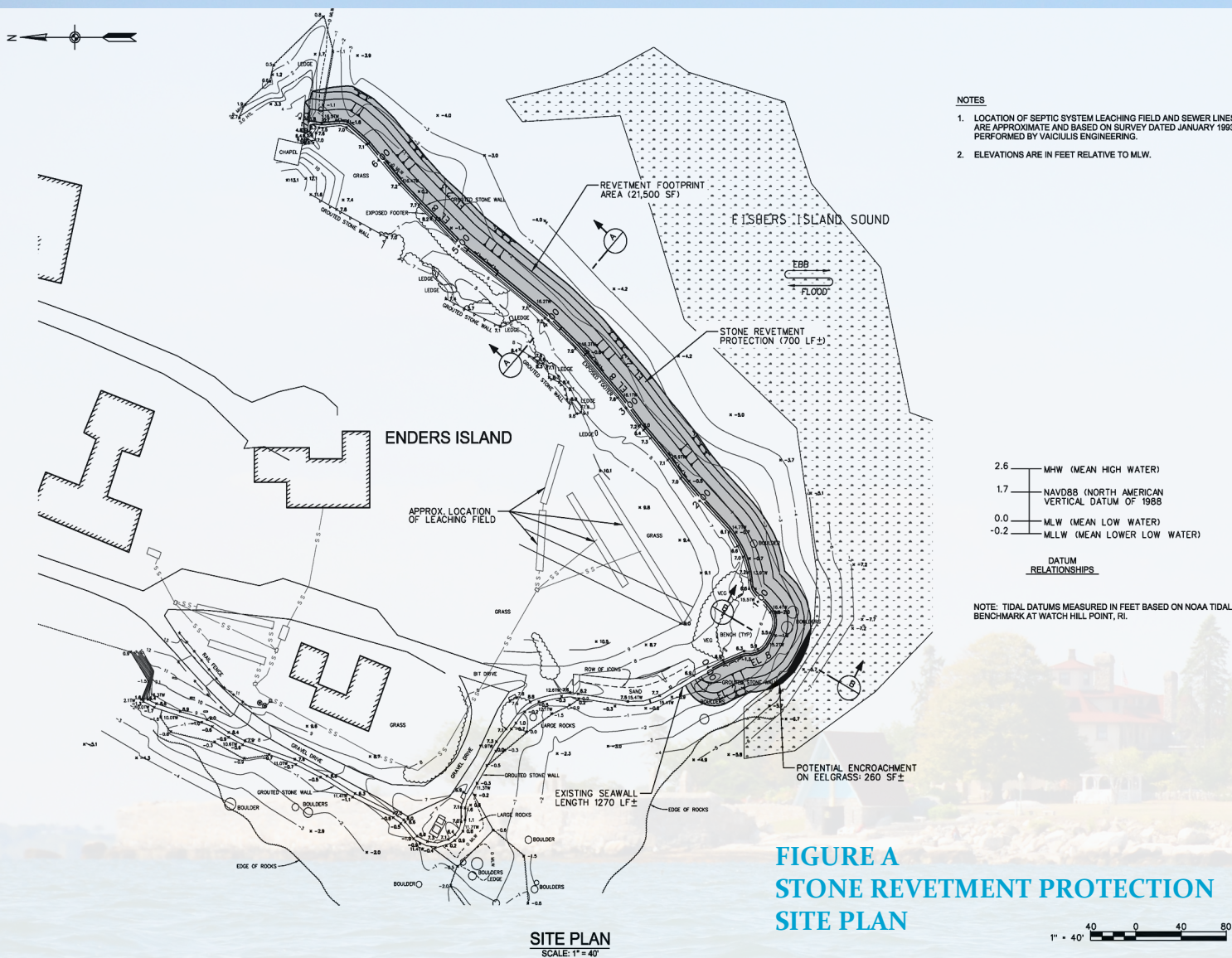

## HISTORY

1942 | Seawall first erected

1991 | Minor repairs completed by the Society of St. Edmund as concerns grow for the seawall's viability

1996 | Planning commences for the seawall restoration

2003 | St. Edmund's Retreat becomes incorporated as an independent Catholic nonprofit ministry of hope & healing

2004 | Board commissions plans for seawall renovations

2005 | Docko begins an engineering analysis of the seawall

2006 | US Army Corps of Engineers begins investigating the Seawall Project

2012 | Hurricane Sandy breaches the wall & undermines integrity

2016 | Town of Stonington pledges support for the project

June | Enders Island begins issuing IPOs

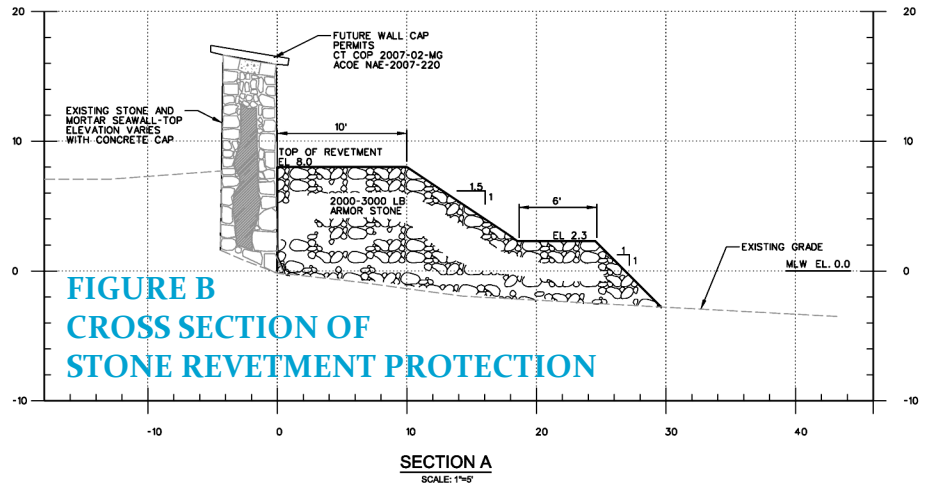

## BECOME PART OF THE STORY

The Seawall surrounding Enders Island was originally completed in 1942 by Elliott and Watrous Construction Company in the wake of the 1938 hurricane. Originally, the Seawall was as high as sixteen feet in some places, to prevent overwash and the erosion of Mrs. Enders' beautiful grounds. Since that time, the Seawall has withstood decades of buffeting and turbulent waves—a visible analogy for the ministry of Enders Island—protecting the Island from the ravages of tides and the sea's fury. So too, our ministry helps protect the lives of many from the turbulence and storms they encounter throughout their lives; offering them the safe harbor of healing and hope.
